5 DISPUTES REFERRED TO THE COURT

In 2009, six disputes were referred to the Court.

The <u>first dispute</u> was an ex-parte application of a non-NTUC affiliated union seeking extension of a hotel's collective agreement ("CA") with variations to provide higher salary ranges and lump sum payment in lieu of wage increases for employees whose salaries had exceeded the maximum points of their salary ranges. At the hearing, the union alleged that a group of long service employees was not given wage increase as their salaries had exceeded the maximum points of their salary ranges. The union contended that the hotel had wrongfully applied the maximum salary points to bar the employees from receiving a wage increase as previous NWC wage increases, since 1979, were not added to the salary ranges. The union proposed adding the previous NWC wage increases to the salary ranges as that would offer a new set of salary ranges with maximum points higher than the existing salaries thus enabling the employees to be eligible for future wage increases. The hotel rejected the union's proposal as being unreasonable and without basis and maintained that the previous NWC wage increases were already added to the salary ranges during the renewal of the CAs over the years. The hotel submitted to the Court the salaries paid by comparable class of hotels to show that the salaries of their long service employees were already above market rates. The hotel objected to adding the previous NWC wage increases to the salary ranges as that would further raise the salaries by 5% to a level 45% higher than market rates for the various jobs, to the disadvantage of its business. The hotel was also against the extension of the CA as 6 clauses were still outstanding with no agreement reached. As both parties were unclear and in disagreement over how the previous NWC wage increases should influence the maximum salary points, the matter was adjourned by the Court for them to seek clarification from the Ministry of Manpower ("MOM") and the Singapore National Employers Federation ("SNEF") on the issue.

When hearing resumed, the Court inferred from the inputs of the MOM and the SNEF that there was no direct relationship between the adjustment to the minimum and maximum salary points of the salary ranges and the NWC wage increases given. The NWC's guidelines and recommendations were only one of many relevant factors to be taken into account for determining the maximum salary points of the various jobs. The NWC's recommendations did not exclusively determine nor were they the predominant factor for establishing the maximum salary points. therefore did not mean that the maximum salary points had to move in tandem with the NWC's recommendations and that their adjustments were to be directly correlated with the quantum of increase stipulated therein. The Court noted that some of the maximum salary points proposed by the union were much higher than those of hotels of a similar class. The Court did not support the union's proposal to add the previous NWC wage increases to raise the maximum salary points of all the salary ranges. The union's application for the extension of the CA was not approved by the Court on the basis that it was without merit. The Court urged the parties to commence fresh negotiations in good faith, to adopt a holistic approach and to show flexibility in resolving the various maximum salary points in the salary scales for the various jobs. Certain key economic and business factors were spelt out by the Court for the parties to take into consideration in their negotiations.

The <u>second dispute</u> arose from the refusal of a company to conclude a CA with its union. Despite having settled almost all the clauses after 2 years of negotiations, the company abruptly discontinued negotiations and ignored the MOM's call to resume negotiations. The company also refused to sign a joint application with the union to refer the dispute for arbitration. The Minister for Manpower then directed the case to the Court for determination. The company was not receptive to mediation by the Registrar. The President, sitting with panel members, then heard the case.

The company contended as follows in Court. Its employment terms and benefits were favourable and in accordance with the law and there was no necessity to have a CA. The company considered having a CA onerous. It did not wish to be compelled by a CA to offer fixed terms and benefits contrary to the flexible wage system recommended by the NWC. As other local companies in the same industry had no CAs, it did not wish to be the first to sign a CA with a union - for fear of losing its competitiveness and later having to conclude similar agreements with its overseas companies which currently had no CAs. The company insisted that it should not be coerced into signing a CA with the union, especially since it was not a requirement under the law to have one. The union contended as follows. The company's decision not to have a CA was dangerous because, if others were to adopt the same position, there could eventually be no signing of CAs with unions, to the detriment of workers. Once given recognition by the company, it was the union's right to initiate collective bargaining and the obligation of the company to respond and this should culminate in the signing of a CA as provided under the Act. The union reiterated the fundamental right of workers to freedom of association and collective bargaining as enshrined under the Constitution of Singapore, the Act and the International Labour Convention (ILO No.98), 1949 on the Right to Organise and Collective Bargaining which Singapore had ratified. The union disputed the company's contention that a CA would impose onerous obligations on employers to render their companies uncompetitive by pointing out that the unions were not irresponsible or unreasonable. The union added that 96% of unionised companies had a flexible wage system and unions accepted flexibility in the wage structure and supported wage cuts during the recent economic downturn. The Court's attention was drawn to 2 "anti-union" incidents. The first was when the company had transferred workers to another firm, when part of its business was sold, without notifying the union. The second was when the company had attempted to have workers, who were being retrenched last year, to sign a

letter rejecting union representation. The union expressed disappointment with the company and maintained that the company should not be exempted from having a CA on the grounds that others did not have one.

In handing down the award, the Court explained the provisions and the mechanisms relating to negotiation, conciliation and arbitration under the Act. The Court did not agree with the company that entering into a CA with the union on terms that both had agreed, after negotiation or conciliation, was onerous or coercive. The Court explained that either party was at liberty, under the legal processes, to refer any proposal or claim in dispute for conciliation or arbitration. The Court, if need be, would make the final and binding decision on the position considered reasonable and fair for the parties. The Court rejected the company's contention that it was unnecessary to have a CA. The Court stressed that it would be insufficient to provide attractive salaries and conditions of employment unless they were contained in an enforceable CA - to make clear what they were - to protect and safeguard the interests of both parties and to enhance industrial peace and stability in Singapore. The Court found no evidence placed before it by the company to support its claim that having a CA will per se lead to erosion of flexibility and loss of competitiveness. The Court made the following observations. Numerous companies from all sectors in Singapore, including large multinational ones, had CAs with their unions. They were at liberty to propose the flexibilities they wanted in the provisions of the CAs to address concerns and meet the needs. Disagreement on any provision being negotiated could be referred to the Court for resolution. The Court also found a lack of good faith on the part of the company as it had, through a memorandum of understanding ("MOU"), agreed to establish a CA on the expiry of the MOU but instead abruptly called off negotiations. The Court noted that the company had failed to provide a satisfactory reason to the Court why it could not enter into a CA on those terms which were agreed, leaving out those terms

which could not be agreed to be adjudicated upon later by the Court, if required. The Court also found that the company had failed to furnish any evidence to the Court to suggest that the union had been in any way irresponsible or unreasonable, imposed any onerous obligations on management or proposed any clauses that were so unreasonable as to render the company uncompetitive. The Court was of the opinion that the company had breached its obligation to negotiate in good faith with the union simply because it did not want to have a CA at all. The Court reiterated the importance of the obligations of both the employer and the union to negotiate in good faith for the maintenance and development of harmonious labour relations and that delay tactics in negotiations should be avoided. On the 2 "anti-union" incidents cited by the union, the Court stated that such conduct of the company would not have assured workers that they would always be treated fairly and hence it was all the more necessary to have a CA to specify the rights and obligations of both parties as well as safeguard the rights of the workers. In a unanimous decision, the Court ordered the company to negotiate with the union in good faith with a view to reaching a settlement speedily on the terms that had been proposed and discussed within a month and, upon reaching an agreement, to voluntarily sign a CA with the union within a week thereafter on those agreed terms. For terms where no agreement could be reached, the parties were advised to resolve them through conciliation and return to the Court for arbitration, if required. Within a month, the parties reached agreement on all the terms, signed the CA and had it certified by the Court.

The <u>third dispute</u> was a joint application concerning the non-payment of pro-rated annual wage supplement ("AWS") to some retrenched workers of a company. The company had retrenched its last 2 batches of workers and moved its plant to Johore, Malaysia due to poor business as a result of the global financial crisis in late 2008. The company refused to pay the pro-rated AWS to these 2 batches of workers on the basis that it was not

obliged to do so under the CA and would rather preserve the cash for future business use. The union contended that they were the last to be retrenched because they were the better workers and it would be unfair not to pay them the pro-rated AWS when those who were retrenched earlier were paid. The Registrar mediated the case and the company was persuaded to offer a lump sum settlement which was accepted by the union on behalf of the retrenched workers. The parties then withdrew their joint application.

The <u>fourth dispute</u> was a union's application for the extension of an expired CA to safeguard the workers' entitlement to retrenchment benefits. Workers were being retrenched while the Assistant Registrar was in the midst of mediating the case. The Assistant Registrar successfully mediated and secured retrenchment benefit payments for the retrenched workers at a lower quantum. The union later withdrew its application as all its members had been retrenched with the cessation of the company's operations in Singapore.

The <u>fifth dispute</u> was a union's application against a company for non-compliance with a CA in respect of overtime payment, salary increment, annual wage supplement, dental benefits, insurance coverage, annual leave, sick leave and marriage leave. The union informed the Court after the lodgment of the application that the dispute was still under conciliation. The case was accordingly held in abeyance.

The <u>sixth dispute</u> was a joint application of a union and a company over proposed changes to the quantum of the annual variable payment. The case, which was lodged in November, was carried over to the following year for mediation.

6 COLLECTIVE AGREEMENTS CERTIFIED BY THE COURT

Four hundred and eight CAs were filed with the Court in 2009, as compared to 355 CAs in 2008. Together with the 22 CAs brought forward from 2008, a total of 430 CAs were dealt with, of which 384 were certified by the Court. Thirteen of the certified CAs involved public sector employees. There were 46 CAs pending certification at the end of the year.

7 VARIATION OF COLLECTIVE AGREEMENTS

In 2009, 10 applications were filed with the Court for variation of CAs. The number was the same as in 2008.

All the 10 applications were approved. A breakdown of the applications by particulars is as follows:

8 DISPUTE REFERRED TO REFEREES

9 EMPLOYEES' RETIREMENT AGE

Three hundred and two of the 408 CAs filed with the Court in 2009 contained provisions for retirement age at or above the statutory minimum age of 62. A breakdown by age is as follows:

10 DURATION OF COLLECTIVE AGREEMENTS

The Act provides that a CA shall be in force for a period not less than two years or more than three years from the date on which it is expressed to come into force. Of the 408 CAs filed with the Court in 2009, 300 had a duration of three years, 89 a duration of two years and 19 a duration of between two and three years.

A breakdown of the CAs by duration for the past 3 years is as follows:

In 2009, only 37 of the 408 CAs filed with the Court entered into force on a prospective date. Two hundred and twenty-six CAs had retrospective operation from their dates of execution for a period of six months or less. One hundred and forty-five of the CAs had retrospective operation for a period of more than six months.

Of the 145 CAs with more than six months of retrospective operation, 96 had retrospective operation for six to twelve months, 33 for thirteen to eighteen months, 11 for nineteen to twenty-four months and 5 for more than twenty-four months.
