

5 DISPUTES REFERRED TO THE COURT

In 2015, two new disputes were referred to the Court. The Court had to deal with a total of four cases, two of which were carried forward from the previous year. All four cases were successfully mediated by the Registrar.

Of the four cases, two involved First Defense Services Pte Ltd and the Singapore Industrial & Services Employees Union. The disputes involved the payment of annual increments for 2012, 2013 and 2014. Upon mediation by the Registrar, the parties reached an amicable settlement and withdrew the applications accordingly.

The third case was carried forward from 2014. The Building Construction and Timber Employees' Union had filed for an order against LHT Holdings Limited, to show cause why the latter should not be ordered to comply with two clauses of the newly signed Collective Agreement. These two clauses pertained to the payment of Employee Service Awards and recognition of an employee's medical leave. After clarification and mediation by the Registrar, the parties reached a settlement, and the Union withdrew the application after the Company had made the necessary payments.

The last case was an ex-parte application submitted by the Singapore Manual & Mercantile Workers' Union for the continuation of a collective agreement with Malaysian Airline System Berhad for two more years. The parties had been negotiating for a new collective agreement when it was announced that the Company would be ceasing its operations on 31 August 2015. Though the parties subsequently came to an agreement over the retrenchment benefits for the affected employees, the Union needed the collective agreement to be in force so that they would have the legal right to take action should the Company not fulfil its agreement. During mediation, the Registrar assured the Union that since the case had been formally lodged, the case could still proceed to arbitration should the Company not make the necessary payments on the agreed date. Subsequently, the Company made the payments as agreed, and the Union withdrew the application accordingly.

In summary, 4 cases were successfully mediated by the Registrar in 2015.

6 COLLECTIVE AGREEMENTS CERTIFIED BY THE COURT

438 Collective Agreements ("CAs") were filed with the Court in 2015, an increase of 13 CAs over the previous year. Together with the 75 CAs brought forward from 2014, a total of 513 CAs had to be processed and certified. Out of these CAs, 479 were certified by the Court and 14 of them involved public sector employees. At the end of 2015, there were 34 CAs pending certification.

7 VARIATION OF COLLECTIVE AGREEMENTS

In 2015, seven variations of CAs were filed with the Court compared to four applications in 2014. All seven variations were approved.

8 DISPUTES REFERRED TO THE REFEREES

There was no dispute referred to the Referees of the Court.

9 DURATION OF COLLECTIVE AGREEMENTS

The Act provides that a CA shall be in force for a period not less than two years or more than three years from the date on which it is expressed to come into force. Of the 438 CAs filed with the Court in 2015, 316 CAs had a duration of three years, 89 had a duration of two years and 33 had a duration of between two and three years.

A breakdown of the CAs by duration for the past 3 years is as follows:

In 2015, out of the 438 CAs filed with the Court, 65 CAs had prospective operative dates, 246 CAs had retrospective operative dates of six months or less and 127 CAs had retrospective operative dates of more than six months.
