5 DISPUTES REFERRED TO THE COURT

In 2018, one dispute was referred to the Court. The case involved C&P Transport (Pte) Ltd and National Transport Workers' Union. Despite many rounds of negotiation from 2015 to 2018, the parties could not reach an agreement on the annual increment for 2015, 2016 and 2017. The union then submitted the dispute for arbitration.

After mediation by the Registrar, the parties came to a settlement on the annual increment to be paid. However, payment was not effected following the agreed schedule. A court hearing was therefore fixed. Eventually, the company made the payment before the court hearing and the union withdrew its application.

6 COLLECTIVE AGREEMENTS CERTIFIED BY THE COURT

383 Collective Agreements ("CAs") were filed with the Court in 2018, a decrease of 36 CAs over the previous year. Together with the 63 CAs brought forward from 2017, a total of 446 CAs had to be processed and certified. Out of these CAs, 398 were certified by the Court and 13 of them involved public sector employees. At the end of 2018, there were 48 CAs pending certification.

7 VARIATION OF COLLECTIVE AGREEMENTS

In 2018, five variations of CAs were filed with the Court compared to seven applications in 2017. All five variations were approved.

A breakdown of the variations is as follows:

There was no dispute referred to the Referees of the Court.

9 DURATION OF COLLECTIVE AGREEMENTS

The Act provides that a CA shall be in force for a period not less than two years or more than three years from the date on which it is expressed to come into force. Of the 383 CAs filed with the Court in 2018, 306 CAs had a duration of three years, 64 had a duration of two years and 13 had a duration of between two and three years.

A breakdown of the CAs by duration for the past 3 years is as follows:

In 2018, out of the 383 CAs filed with the Court, 57 CAs had prospective operative dates, 222 CAs had retrospective operative dates of six months or less and 104 CAs had retrospective operative dates of more than six months.
