5 DISPUTES REFERRED TO THE COURT

In 2007 six disputes were referred to the Court. With one dispute brought forward from the previous year, there were seven disputes before the Court.

Six of the seven cases were settled or withdrawn. The remaining case was carried forward to the next year.

Three of the six resolved cases involved our national airline, its pilots' union and the new Airbus A380 ("the A380"). The first of these three cases was heard in May 2007 by the President of the Court, Justice Tan Lee Meng, sitting with panel members. It was a joint application by the parties for determination of the A380 salary ranges, the pilots' productivity allowances, flight time limitations and the instructor pilot's allowance. The case attracted much global attention. Many international airlines were monitoring the salaries that our national airline, being the first in the world to fly the A380, would have had to pay its pilots to fly the world's largest commercial jet.

The company contended that the advanced technology and high level of automation of the A380 had made it as easy to fly as the older and smaller Boeing 747-400 aircraft ("the B744"). Some test pilots' views and comments, extracted from magazines, endorsing the easy maneuverability of the A380 were cited. The company submitted as follows. It would prefer not to continue the long established practice of providing a new and different salary range for flying a new type of aircraft like the A380. The company wanted to follow other airlines and pay a common basic salary to all its pilots regardless of the type of aircraft they flew. That would provide greater operational and scheduling flexibility as well as enhance the airline's competitiveness. The company contended, using payroll data, that their pilots' salaries were already high compared to senior management staff and their total salaries accounted for a significant portion of the company's high operating costs. In view of the above and as a new collective agreement was due for negotiation, the company sought the Court's approval to pay the pilots selected to fly the A380 the same salary as B777 pilots i.e. \$9,300 - \$15,300 for captains and \$5,150 - \$8,500 for first officers.

The pilots' union ("the union") rejected the company's proposals. It demanded a new salary range specifically for the A380 fleet, of \$13,100 - \$21,615 for captains and \$8,000 - \$14,355 for first officers. The union contended that to fly the bigger and heavier A380, the pilots had to face higher risks, shoulder greater responsibilities and be accountable for more passengers, crew and overall safety. The union was indifferent to the company's proposed common basic salary scale for all pilots. The union also sought the increase of the productivity allowance (from the existing \$55 per hour for captains and \$36 for first officers to \$60 for captains and \$40 for first officers, and a guaranteed 70-hour allowance) and the instructor pilot allowance (from the existing rate of between \$1,800 and \$2,900 to between \$2,250 and \$3,700) for A380 pilots.

The company refused any increase in the two allowances. The company made an offer immediately before the conclusion of the three-day hearing. It raised the maximum point of its proposed A380 pilot's salary scale to that of the B744 i.e. \$16,500 for captains and \$9,250 for first officers. Additionally, it offered to raise the maximum salary points of all captains and first officers from non-B744 and A380 fleets to the maximum of \$16,500 and \$9,250, respectively.

The company contended that the change would immediately benefit 80 per cent of the airline's existing pool of about 2,000 pilots. The union declined the offer.

The Court, in making its award, stated that, in the absence of empirical data and taking a cautious approach, it had decided that A380 pilots should be offered terms and conditions of those of the B744 fleet with the following modifications:

- the minimum salary point for captains and first officers on the A380 salary range will be \$700 and \$450 more than the minimum salary point for the B744 salary range, respectively;
- (b) all captains and first officers moving to the A380 range of salaries who are already on or above the minimum salary points for their positions on the B744 salary will have their monthly salaries increased by \$700 and \$450, respectively; and
- (c) the maximum salary point for captains and first officers on the A380 salary range will remain at \$16,500 and \$9,250, respectively. However, if on moving to the A380 fleet, a captain's salary or first officer's salary should, with the addition of the \$700 or the \$450 respectively to their salary exceed \$16,500 or \$9,250 respectively, they will be entitled to the amounts on a personal-to-holder basis.

On the productivity allowance and the instructor pilot allowance, the Court ruled in favour of the company not to change but to maintain the prevailing rates.

The second and third cases, lodged by the same union, both concerned the A380 award handed down by the Court on 25 May 2007. In the second case, the union sought the Court's interpretation of the A380 award. In the third case, the union sought the Court's variation of the collective agreement to conform to its interpretation of the A380 award.

The second case was heard by the Court's new President, Justice Chan Seng Onn, sitting alone. The union and the company disagreed on how paragraph 8 of the A380 award should be interpreted for implementation. The union contended that while the Court's award stated that all B744 captains and first officers selected to fly the A380 were to be paid \$700 and \$450 more respectively, it was however silent on the amount payable to B777 and A340 pilots selected to fly the aircraft. The union submitted that all B777 and A340 pilots selected to fly the A380, being a "higher fleet", ought to be granted a promotional increment and be paid more i.e. \$1,400 for captains and \$900 for first officers. The company disagreed. It submitted that B777 and A340 pilots selected to fly the A380 should be paid the same amount as B744 pilots as the award did not differentiate otherwise.

The President of the Court stated that the conversion to a new aircraft might not necessarily be a promotion and that the Court had then actually refrained from classifying the A380 as a higher fleet than the B744. The Court merely considered the conversion of any pilot on any fleet to fly the A380 as a "move" to fly the A380 on certain terms as set out in the award. Based on the

reading of all the transcripts and the parties' submissions at that hearing, the conversion exercise to the A380 was not meant to be limited to B744 pilots but to cover all pilots from all fleets. Hence, paragraph 8 of the award had comprehensively set out the conversion terms for all pilots from all fleets without exception. The President provided some numerical examples on the interpretation of paragraph 8 of the award and gave guidance to the parties on how to operationalise it. Based on the President's interpretation of the award, all B777 and A340 captains and first officers selected to fly the A380 would be paid \$700 and \$450 more respectively and not a promotional or double increment. The pilots who did not attain the minimum salary points after the adjustments would be paid the minimum salary of the A380 scale i.e. \$10,700 for captains and \$6,050 for first officers. Captains and first officers already earning more than the maximum salary of \$16,500 and \$9,250 respectively would also be granted the adjustments personal to themselves. The President clarified that, in interpreting the award, the Court had not in any way varied or modified the original terms of the award. After further clarifications on the interpretation were provided to the parties, the union indicated that it would not pursue its application for variation of the collective agreement and that resulted in the withdrawal of the third case.

The fourth case, heard by the President of the Court sitting alone, was on a union's appeal against a Referee's decision. At the hearing, the union questioned the basis of the Referee's decision, in particular on the Referee not ruling on the disciplinary action of a hotel over the redeployment of a room stewardess as an F & B stewardess with deduction of her salary and service points. The union viewed the redeployment as a violation of the collective agreement and a breach of her employment contract. The union also disputed the Referee's position that the Referee had no jurisdiction under the collective agreement to rule on an individual disciplinary case of that nature. The Court, after considering the submission of the union, stated that it did not find anything amiss with the Referee's decisions. The President of the Court, after explaining the rationale of the Referee's ruling to the union, dismissed its appeal.

The fifth case was an ex-parte application from a union seeking NWC 2006 wage increase for a small group of employees. The union alleged that the hotel had denied the group of employees their wage increase because they were at the maximum of their salary scales. The hotel contended that, as the group of employees was already paid salaries above market rates, there was no need to grant them a further wage increase. After mediation by the Assistant Registrar, the hotel agreed to make a variable productivity payment to all employees, including the group, in the following year. That led to the resolution of the dispute and the withdrawal of the union's application.

The sixth case was an ex-parte application lodged by a union for the Court to order its collective agreement with a company to continue in force with certain variations for another three years from the date of its expiry. The union's action arose from the refusal of the company to sign the newly concluded agreement. The parties however resolved the matter before the scheduled mediation of the case by the Assistant Registrar. The parties later submitted their new collective agreement for certification and the union withdrew its application.

The seventh case relating to a dispute over NWC 2007 wage increase was lodged at end November. It had to be carried forward to be dealt with the following year.

6 COLLECTIVE AGREEMENTS CERTIFIED BY THE COURT

426 collective agreements were filed with the Court in 2007 compared with 376 agreements in 2006. Together with the 36 collective agreements brought forward from 2006, a total of 462 agreements were dealt with, of which 440 were certified by the Court. 13 of the certified collective agreements involved public sector employees. One agreement was withdrawn by the parties. There were 21 agreements pending certification at the end of the year.

7 VARIATION OF COLLECTIVE AGREEMENTS

In 2007, 11 applications were filed with the Court for variation of collective agreements compared to 14 applications in 2006.

All the 11 applications were approved. A breakdown of the applications by particulars is as follows:

8 DISPUTE REFERRED TO REFEREES

A Referee heard a union's allegation against a hotel for breach of contract and violation of the collective agreement arising out of the redeployment of a room stewardess as an F & B stewardess. The union perceived the redeployment as outside of the scope of her job definition and as such a breach of her employment contract. The union also contended that the hotel had altered the terms of employment of the room stewardess without its agreement, thereby breaching clause 6(3) of the collective agreement. The union sought a reinstatement of the employee to her original position of room stewardess with no loss of pay or benefits. The hotel disputed the union's allegations and contended that the redeployment of the aggrieved employee was a fair penalty on account of her misconduct, her past adverse record and her failure to abide by numerous written warnings. The hotel stated that the redeployment was meant to be a final opportunity given to her, on compassionate grounds, to work until retirement instead of facing dismissal.

The Referee, based on a study of the collective agreement and taking into account the submissions of the parties, made the following observations:

- (a) clause 6(3) of the collective agreement did not require the hotel to seek the union's consent before implementing changes to the aggrieved employee's terms of employment. It merely required the hotel to inform the union what was done. The said clause was directed at changes affecting the "general conditions of employment" of employees rather than mere changes to the terms of an individual employee following a disciplinary action; and
- (b) clause 9 of the collective agreement defined matters to be referred to a Referee as those limited to complaints by the union or the hotel for "alleged violation of the collective agreement" or to disputes which "arise out of the operation of the collective agreement". Under this clause, a Referee had no jurisdiction to decide a private dispute involving a plain breach of contract between the hotel and any of its individual employees, as opposed to a breach by the hotel of a specific provision of the collective agreement.

The Referee ruled that the hotel had not acted in breach of clause 6(3) of the collective agreement. The Referee also decided that he had no jurisdiction to rule on the union's complaint that the hotel had acted in breach of the employment contract between itself and the aggrieved employee. He pointed out that the grievance procedure, provided under clause 8 of the collective agreement, to look into the complaint involving breach of contract ended with the conciliation efforts by the Ministry of Manpower. (The union's appeal against the Referee's decision was dismissed by the President of the Court.)

9 EMPLOYEES' RETIREMENT AGE

301 of the 426 collective agreements filed with the Court in 2007 contained provisions for retirement age. A breakdown by age is as follows:

A total of 300 collective agreements provided for retirement at or above the statutory minimum age of 62. One collective agreement which provided for retirement age of 50 covering emergency officers working at the airport had the approval of the then Minister for Labour in 1998.

10 DURATION OF COLLECTIVE AGREEMENTS

The Act provides that a collective agreement shall be in force for a period not less than two years or more than three years from the date on which it is expressed to come into force. Of the 426 collective agreements filed with the Court in 2007, 309 had a duration of three years, 102 a duration of two years and 15 a duration of between two and three years.

A breakdown of the collective agreements by duration for the past 3 years is as follows:

In 2007, only 25 of the 426 collective agreements filed with the Court entered into force on a prospective date. 218 collective agreements had retrospective operation from their dates of execution for a period of six months or less. 183 of the collective agreements had retrospective operation for a period of more than six months.

Of the 183 collective agreements with more than six months of retrospective operation, 118 had retrospective operation for six to twelve months, 43 for thirteen to eighteen months, 16 for nineteen to twenty-four months and 6 for more than twenty-four months.
