#### 5 DISPUTES REFERRED TO THE COURT

In 2011, twelve disputes were referred to the Court. A total of fourteen disputes were brought before the Court, including 2 that were carried forward from the previous year.

Of the 14 disputes, 5 involved the Singapore Airlines and its subsidiaries. The <u>first</u> case involved Singapore Airlines Ltd and the pilot's union over service increment for 2010. At the hearing, the management stressed that the service increment of the pilots should be tied to the company's financial position. It also asked for the service increment date of the pilots to be shifted from January to July to be in line with the others, i.e., the administrative staff, cabin crew etc. The pilot's union insisted that the service increment was a payment in recognition of the pilots' service and loyalty to the company and objected to the proposed shifting of the service increment date from January to July. After hearing their arguments, the Court urged the parties to settle the dispute. The case was adjourned for 5 weeks for both parties to re-negotiate and resolve the dispute. Subsequently, the parties informed the Court that they had settled the service increment for 2010 and 2011. The parties then withdrew their application.

The <u>second</u> case also involved Singapore Airlines Ltd. It was over the interpretation of "basic salary". The company and the pilot's union could not agree on the interpretation of "basic salary" for the purpose of computing both the Profit Sharing Bonus (PSB) and the Annual Wage Supplement (AWS) arising out of the Monthly Variable Component (MVC) cuts made to the pilots' salaries (from August 2009 to April 2010). At the hearing, the company cited clauses of its 2009 Collective Agreement that had defined "basic salary" to include MVC, which could be adjusted according to the company's key performance indicators. The company's position was that the computation of

the PSB and AWS should be based on the basic salary as adjusted for MVC cuts. The pilot's union, however, held the view that the basic salary to be used for computation of the PSB and AWS should include a fixed amount comprising 10% of the bonusable components of salary, regardless of any MVC cuts made. After deliberating on the facts and arguments submitted by both parties, the President ruled in favour of the company - that adjustments to the MVC incorporated within the monthly basic salary payable to the pilots should be similarly factored into the computation of AWS and PSB. The President also pointed out that the Collective Agreement did not except or exclude AWS and PSB payments from the new basic salary structure that was agreed by the parties.

The third case concerned the Singapore Airlines' regional carrier, SilkAir (Singapore) Pte Ltd, regarding computation of the productivity allowance of its pilots. At the hearing, the pilot's union complained that the existing method of computing the pilots' productivity allowance based on flying hours was unfair in that it favoured pilots operating a longer flight with payment of higher allowances than those operating two short flights. In pressing for a more equitable system, the pilot's union proposed that the flying allowances be calculated from the time a pilot reported for duty at the flight operations centre until the end of his shift. The pilot's union argued that computation of the productivity allowance based on total duty hours would be fairer since it would also take into consideration delays that may be caused by the weather or other reasons. The pilot's union told the Court that its members would be prepared to accept a lower rate of allowance to make it cost-neutral for the airline should the basis of computation of the productivity allowance be changed from flying hours to flight duty hours. In response, the airline told the Court that computation of the productivity allowance based on flying hours had worked well over the years and must not be changed because of the direct linkage of flying hours to the Company's competitiveness. The Company objected to the use of productivity allowance to reward working hours on the ground as that would increase costs and erode the airline's competitiveness, among other things. The Court found

the case presented by the pilot's union flawed in principle. The Court stressed the need to distinguish between actual flying hours, which contributed directly to productivity, and flight duty hours, which included the waiting time in transit and delays. The Court noted that the pilot's union's proposal to pay the productivity allowance for total duty hours as opposed to actual flying time was not going to solve the wide difference in the allowance between the highest and lowest earning pilots. The Court was of the view that implementing a more equitable and transparent rotational system might help to narrow the differences in the productivity allowance of the pilots when averaged over a longer term. The dismissal of the pilot's union's application meant that the productivity allowance would continue to be computed based on flying hours.

The <u>fourth</u> case, which also involved SilkAir, related to the quantum of service increment for the pilots for 2010, as well as the proposed shift in the service increment date from January to July. Both parties, however, managed to reach a settlement just before the scheduled hearing.

The <u>fifth</u> case involved the Singapore Airlines' air cargo carrier-Singapore Airlines Cargo Pte Ltd. Singapore Airlines Cargo had, due to the global economic downturn, suffered heavy financial losses from 2008 to 2010. It could only offer to pay a lump sum instead of a built-in salary increment to all its employees for 2009. While the 2 unions of the company (one representing its executive/administrative staff and the other its general staff) had settled for the lump sum payment, the pilot's union insisted on being given a built-in increment or a huge lump sum payment which the company was not prepared to offer. However, just before the scheduled hearing of the case, the company and the pilot's union reached a settlement. They also signed their first collective agreement. The case was subsequently withdrawn.

The <u>sixth</u> case was Building Construction and Timber Industries Employees' Union's claim for a higher quantum of retrenchment benefits for 6 retrenched employees of a construction company. At the hearing, the company, Sembawang Engineers and Constructors Pte Ltd insisted that it was not obliged to pay any further retrenchment benefits after having paid the employees a week's pay for each year of service when they were retrenched. The union complained to the Court that the company had failed to negotiate the quantum of retrenchment benefit with the ex-employees as required under their collective agreement. The union also asked that the ex-employees be paid one month's pay for each year of service. The Court ruled that the company had no right to determine unilaterally and arbitrarily whether to pay the ex-employees and the quantum of their retrenchment benefit. The Court ordered the company to pay the ex-employees an additional one week's pay for each year of service plus a lump sum of \$350 for each year they could have continued working until they attain the statutory retirement age of 62.

The seventh case was an ex-parte application by The Singapore Catering Services Staff & Workers Trade Union for an order for continuation of Allson Hotel Singapore's collective agreement for a period of 3 years with the exception of the clause pertaining to salary range for which the union proposed variations. The union contended that the hotel had not incorporated the NWC wage increases from the year 2004 onwards into the salary range, hence depriving the group of long-serving employees who had reached the maximum of the salary scale from getting any salary increment. The union insisted that these employees should continue to be given salary increments. Allson Hotel argued that it had taken into account the NWC wage increases and had adjusted the minimum and maximum points of the salary ranges upon renewal of the collective agreement over the years. The hotel also claimed that the maximum salary points for the various job categories were comparable to those for similar jobs in other hotels of the same class as Allson Hotel. The Court was satisfied with the evidence presented by the hotel and dismissed the union's application. The Court also advised the parties to expeditiously negotiate and conclude a new collective agreement.

The <u>eighth</u> case was a joint-application of Singapore Refining Company Pte Ltd and its house union for determination of two items, namely (a) the quantum of service increment payable for 2011 and (b) the amount of adjustment to the salary structure for their new collective agreement. As mediation could not break the impasse, the case was scheduled for hearing in March 2012.

The <u>ninth</u> case related to the union's claim against the National Aviation Company of India Ltd (Singapore Branch) for encashing the unconsumed annual leave of some retrenched employees at a lower rate than expected. The case was also scheduled for hearing in March 2012.

The <u>tenth</u> case related to disputes over the annual increment for 2011 and bonus payments for 2010 and 2011 for employees of Global Yellow Pages Ltd . The parties had asked for more time to resolve their disputes. The case was thus carried forward to 2012.

The remaining 4 cases, all ex-parte applications from unions for continuation of collective agreements, were mediated by the Registrar and Assistant Registrar. The <u>first</u> case involved a printing company, Standard Form Group of Companies that failed to respond to its union's invitation to negotiate a new collective agreement. Upon the Registrar's advice and persuasion, the company eventually concluded a new collective agreement with the union which provided higher maximum salary points and improved medical benefits. The <u>second</u> case was over a dispute regarding how annual leave ought to be consumed. Upon the Assistant Registrar's advice, the construction company involved, United Premas Group of Companies and its union reached an agreement to allow 50% of the employees' annual leave to be carried forward to the next year but to be consumed by the month of June. The parties then went on to sign their new collective agreement. The <u>third</u> case was a dispute arising out of AP Moller-Maersk Group of companies' insistence not to have documented in their new collective agreement these two items, namely (a) the

limited representation of senior executives and assistant managers, and (b) the negotiation of the retrenchment benefits of senior executives and assistant managers. The Assistant Registrar helped the parties to resolve the disputes. They signed a memorandum of understanding applicable to executives and a new collective agreement applicable to bargainable employees. The <u>fourth</u> case concerned the drafting of the variable bonus clause. With the assistance of the Assistant Registrar, the parties, Asia Offshore Services Pte Ltd and Building Construction and Timber Industries Employees' Union proceeded to resolve the matter. The case was withdrawn by the union on 6 Jan 2012.

In summary, 5 cases were heard by the Court and 5 were settled either by the parties themselves or successfully mediated by the Registrar and Assistant Registrar. At the end of 2011, there were 4 disputes outstanding. Two of these cases were fixed for hearing in March 2012.

#### 6 COLLECTIVE AGREEMENTS CERTIFIED BY THE COURT

Three hundred and fifty eight Collective Agreements (CAs) were filed with the Court in 2011, as compared to 376 CAs in 2010. Together with the 58 CAs brought forward from 2010, a total of 416 CAs were dealt with. Out of these CAs, 342 were certified by the Court. Seven of the certified CAs involved public sector employees. There were 74 CAs pending certification at the end of the year.

#### 7 VARIATION OF COLLECTIVE AGREEMENTS

In 2011, 7 variations of CAs were filed with the Court compared to 11 variations in 2010.

All the 7 variations were approved. A breakdown of the variations is as follows:

#### 8 DISPUTES REFERRED TO REFEREES

There was no dispute referred to the Referee.

#### 9 DURATION OF COLLECTIVE AGREEMENTS

The Act provides that a CA shall be in force for a period not less than two years or more than three years from the date on which it is expressed to come into force. Of the 358 CAs filed with the Court in 2011, 276 had a duration of three years, 81 a duration of two years and 1 a duration of between two and three years.

A breakdown of the CAs by duration for the past 3 years is as follows:

In 2011, only 27 of the 358 CAs filed with the Court entered into force on a prospective date. One hundred and eighty-six CAs had retrospective operation from their dates of execution for a period of six months or less. One hundred and forty-five of the CAs had retrospective operation for a period of more than six months.

Of the 145 CAs with more than six months of retrospective operation, 84 had retrospective operation for six to twelve months, 26 for thirteen to eighteen months, 24 for nineteen to twenty-four months and 11 for more than twenty-four months.

#### 10 EMPLOYEES' RETIREMENT AGE

Two hundred and sixty-three of the 358 CAs filed with the Court in 2011 contained provisions for retirement age at or above the statutory minimum age of 62. A breakdown by age is as follows:

\*This collective agreement provides for retirement age of 50 covering firemen and has the approval of the Minister for Manpower.
