5 DISPUTES REFERRED TO THE COURT

In 2013, four new disputes were referred to the Court. The Court had to deal with a total of seven cases, three of which were carried forward from the previous year.

During the year, two disputes were heard by the Court, one was mediated successfully by the Registrar and two were withdrawn by the parties.

The first case heard by the Court was an appeal by The Singapore Catering Services, Staffs & Workers Trade Union against the decision of the Referee in a case involving an ex-employee of Hollandse Club. The Referee decided that the termination of employment of the former employee was valid and the club was not liable to make any further payment to the employee. The union appealed against this decision. The Court ruled that the termination of the employment was in accordance with the employment contract. The Court noted that while the Club had not fully reimbursed the employee for the costs of specialist care and primary care, it had overpaid the employee for the hospitalisation and surgical expenses. The net result was an over-payment to the employee. In view of the over-payment and the additional ex-gratia payment to the employee, the Court ruled that no further payments were due and dismissed the appeal.

The second case was between First Defense Services Pte Ltd and Singapore Industrial & Services Employees Union. The dispute was over whether the company should pay its employees an annual increment for 2011, and if so, the quantum of the increment. The union argued that the company should grant its employees an increment of 5% as the “excellent” rating of the company’s services was due mainly to the employees’ hard work and contributions. The Union highlighted that no increment had been paid since the company’s incorporation in 2009. The increment would help the employees cope with the rising cost of living. Moreover, the company could afford to give

the increment as it had made a profit in FY 2011. However, the company argued that it could not afford to pay an annual increment in 2011 as it had made losses in FY 2009 and 2010. While it had made a profit in FY 2011, the profit was not sufficient. Furthermore, the company's reserves had to be set aside to meet the potential legal liability from a lawsuit and the risk of a downsizing of its contract with the US Navy arising from the US Government's budget cuts.

The Court decided that the company should pay a built-in increment of \$50 per month to employees earning up to \$2,000 per month, and an increment of 2.5% of monthly basic salary to those earning above \$2,000 per month. The Court took into account the National Wage Council's recommendations which supported granting higher built-in wage increases for lower-salaried workers in order to help them cope with the rising cost of living in Singapore. The overall monthly wage increase of 2.88% would adequately compensate employees for the annual inflation rate of 2.8% for the year 2010. This increase would not be too financially onerous for the company since it almost broke even for the year 2010 and its prospects in the following years appeared to be bright. The Court clarified that in determining the increment for 2011, the parties should consider the company's financial performance and the inflation rate for the previous year ie 2010, and not 2011.

Apart from these two cases heard by the Court, there was an ex-parte application from The Singapore Manual & Mercantile Workers' Union to renew its collective agreement with Bukit Timah Saddle Club which was successfully mediated by the Registrar. The parties settled and later signed a new collective agreement.

Two cases involving The Singapore Manual & Mercantile Workers' Union and Global Yellow Pages Ltd were settled between the union and the company. These cases related to the renewal of the collective agreement and the variable bonus for FY 2012.

There were two cases outstanding at the end of the year. One was an application taken out by Singapore Industrial & Services Employees Union against First Defense Services Pte Ltd to show cause why it failed to comply with an Award made by the Court on 28 March 2013. As mediation was unsuccessful, the case was scheduled for hearing in February 2014.

The second case was a joint application by Singapore Industrial & Services Employees Union and Craft Print International Ltd seeking the Court's ruling on three outstanding clauses in the proposed collective agreement. A meeting was called by the Registrar to mediate the dispute. The parties were in the midst of finalising the collective agreement by the end of December 2013.

6 COLLECTIVE AGREEMENTS CERTIFIED BY THE COURT

423 Collective Agreements ("CAs") were filed with the Court in 2013, an increase of 54 CAs over the previous year. Together with the 121 CAs brought forward from 2012, a total of 544 CAs had to be processed and certified. Out of these CAs, 474 were certified by the Court and 17 of them involved public sector employees. At the end of 2013, there were 70 CAs pending certification.

7 VARIATION OF COLLECTIVE AGREEMENTS

In 2013, two variations of CAs were filed with the Court compared to nine applications in 2012. Both variations were approved.

8 DISPUTES REFERRED TO THE REFEREES

There was no dispute referred to the Referees of the Court.

9 DURATION OF COLLECTIVE AGREEMENTS

The Act provides that a CA shall be in force for a period not less than two years or more than three years from the date on which it is expressed to come into force. Of the 423 CAs filed with the Court in 2013, 333 CAs had a duration of three years, while 81 had a duration of two years and nine had a duration of between two and three years.

A breakdown of the CAs by duration for the past 3 years is as follows:

In 2013, out of the 423 CAs filed with the Court, 31 CAs had prospective operative dates, 203 CAs had retrospective operative dates of six months or less and 189 CAs had retrospective operative dates of more than six months.

11 ORGANISATIONAL EXCELLENCE

During the year, the Court embarked on a major initiative to upgrade the quality of service provided to employers, unions and the general public. The Court's website was upgraded and refreshed in January 2013. It now provides more comprehensive information on the processes for certification of collective agreements and arbitration of disputes. The new website is more readable, user-friendly and easier to navigate. The revamped website drew praise from many companies and union representatives.

To address the incidence of errors made in a large number of collective agreements filed with the Court for certification, the Court embarked on a slew of measures to educate and engage the unions and

companies. The Court also improved the effectiveness and efficiency of its vetting process. The following measures were taken:

- (a) Details on the requirements for collective agreements were provided in the revamped website, including a set of slides giving a quick guide to preparing a collective agreement, a set of Frequently Asked Questions listing the common mistakes made, sample clauses and sample collective agreements for reference by unions and companies.
- (b) A briefing cum dialogue session was held separately with two groups in collaboration with the Ministry of Manpower: a group of 70 union leaders and Industrial Relations Officers, and a group of Human Resource managers and unionists in companies under The United Workers of Petroleum Industry Union cluster.
- (c) Focus group discussions were held with union representatives to gather suggestions for improvement and obtain feedback on the challenges they faced in the collective agreement filing process.
- (d) Three months before the expiry of the collective agreement, the Court would issue guidelines on the preparation of the new collective agreement together with the approved softcopy of the current collective agreement to the respective union and company. Included would also be a checklist for the preparation of the collective agreement and a compilation of relevant provisions in the labour laws, which were not reflected accurately in a number of collective agreements filed previously with the Court.

- (e) The process of vetting of collective agreements was improved to ensure compliance with the Industrial Relations Act and other labour laws, and that there are no major errors or discrepancies in the agreements.
- (f) Clearer and more detailed guidance on the changes to be made were provided where a collective agreement had to be amended.

The number and proportion of collective agreements that had to be amended by the parties started to drop as a result of these measures. Nonetheless, there is still room for improvement and the Court will be monitoring the situation closely with a view to taking further action if necessary.

The Court also gave its inputs to the Ministry of Manpower with respect to the Ministry's on-going review of the Industrial Relations Act.

Going forward, the Court will examine how it can facilitate collective bargaining between unions and employers so as to preserve harmonious industrial relations in Singapore.

12 VISITORS

During the year under review, the Court hosted one group of students from Ngee Ann Polytechnic and another group from Temasek Polytechnic. The Registrar and Assistant Registrar briefed them on the role and functions of the Court.

13 SUPPORTING STAFF OF THE COURT

In addition to the President, the Deputy President, the Registrar and the Assistant Registrar, the IAC had seven supporting staff in 2013 comprising a verbatim reporter, a stenographer, an office supervisor, a management support officer, two corporate support officers and an operations support officer.

14 FURTHER DETAILS

The five statistical tables and three Appendices which follow provide more details of the work of the Court.
