

5 DISPUTES REFERRED TO THE COURT

In 2016, three new disputes were referred to the Court. All three cases were successfully mediated by the Registrar. None of them had to proceed to arbitration.

The first case involved First Defense Services Pte Ltd and the Singapore Industrial & Services Employees Union, over the conclusion of a collective agreement between the parties. Upon mediation by the Registrar, the parties decided to renegotiate and eventually reached an amicable settlement. They signed a collective agreement which was duly certified by the Court thereafter.

The remaining two cases involved WorleyParsons Pte Ltd and the Union of Power and Gas Employees. One was an application filed by the Union to extend their collective agreement which had ceased in force, for a period of two years. Upon clarification and mediation by the Registrar, the parties signed a new collective agreement. The Union withdrew the application accordingly.

The other case was a joint application by the parties over the representation of certain classes of employees by the Union. The Industrial Arbitration Act was amended in April 2015 to allow trade unions to collectively represent eligible executive employees. The Union, which was already representing the rank and file employees of the Company, thus sought to represent certain classes of executives. The Company did not agree to some of these classes, claiming that they were not eligible as defined under the Act. After many sessions of mediation by the Registrar, both parties eventually reached an agreement, where the Company accorded the Union outright recognition to collectively represent the executive employees sought by the Union. Both parties jointly withdrew the application thereafter.

6 COLLECTIVE AGREEMENTS CERTIFIED BY THE COURT

411 Collective Agreements (“CAs”) were filed with the Court in 2016, a decrease of 27 CAs over the previous year. Together with the 34 CAs brought forward from 2015, a total of 445 CAs had to be processed and certified. Out of these CAs, 411 were certified by the Court and 15 of them involved public sector employees. At the end of 2016, there were 34 CAs pending certification.

7 VARIATION OF COLLECTIVE AGREEMENTS

In 2016, five variations of CAs were filed with the Court compared to seven applications in 2015. All five variations were approved.

8 DISPUTES REFERRED TO THE REFEREES

There was no dispute referred to the Referees of the Court.

9 DURATION OF COLLECTIVE AGREEMENTS

The Act provides that a CA shall be in force for a period not less than two years or more than three years from the date on which it is expressed to come into force. Of the 411 CAs filed with the Court in 2016, 286 CAs had a duration of three years, 89 had a duration of two years and 36 had a duration of between two and three years.

A breakdown of the CAs by duration for the past 3 years is as follows:

In 2016, out of the 411 CAs filed with the Court, 80 CAs had prospective operative dates, 201 CAs had retrospective operative dates of six months or less and 130 CAs had retrospective operative dates of more than six months.

A breakdown of the CAs by prospective or retrospective operation is as follows for the past three years:
