5 MATTERS REFERRED TO THE COURT

In 2020, there was no trade dispute submitted to the court for arbitration.

6 COLLECTIVE AGREEMENTS CERTIFIED BY THE COURT

419 Collective Agreements ("CAs") were filed with the Court in 2020, a decrease of 13 CAs over the previous year. Together with the 75 CAs brought forward from 2019, a total of 494 CAs had to be processed and certified. Out of these CAs, 412 were certified by the Court and 5 of them involved public sector employees. At the end of 2020, there were 82 CAs pending certification.

7 VARIATION OF COLLECTIVE AGREEMENTS

In 2020, six variations of CAs were filed with the Court compared to fifteen applications in 2019. Together with the one variation brought forward from 2019, a total of seven variations were approved.

9 DURATION OF COLLECTIVE AGREEMENTS

The Act provides that a CA shall be in force for a period not less than two years or more than three years from the date on which it is expressed to come into force. Of the 419 CAs filed with the Court in 2020, 309 CAs had a duration of three years, 87 had a duration of two years and 23 had a duration of between two and three years.
