# 5 MATTERS REFERRED TO THE COURT

In 2021, the Court received applications under sections 31(d)(ii) and 56 of the Act. The issue was on the payment of Annual Wage Supplement ("AWS"). The Court conducted pre-hearing conferences and mediation sessions, and the disputes were amicably resolved between the parties without the need for a court hearing.

## 6 COLLECTIVE AGREEMENTS CERTIFIED BY THE COURT

424 Collective Agreements ("CAs") were filed with the Court in 2021, an increase of five CAs over the previous year. Together with the 82 CAs brought forward from 2020, a total of 506 CAs had to be processed and certified. Out of these CAs, 391 were certified by the Court and seven of them involved public sector employees. At the end of 2021, there were 115 CAs pending certification.

## 7 VARIATION OF COLLECTIVE AGREEMENTS

In 2021, nine variations of CAs were filed with the Court compared to six applications in 2020. All nine variations were approved.

### 9 DURATION OF COLLECTIVE AGREEMENTS

The Act provides that a CA shall be in force for a period not less than two years or more than three years from the date on which it is expressed to come into force. Of the 424 CAs filed with the Court in 2021, 267 CAs had a duration of three years, 142 had a duration of two years and 15 had a duration of between two and three years.
